Background information

The North Pennines Smallholders (NPS) originated as part of the North Pennines AONB "Nectarworks" project following a series of events at the end of 2013.

The aim is to establish a network across the region that will provide benefits for members, their land/livestock and also the wildlife within it. The NPS hopes to act as a network providing a forum for discussion, a source of mutual help and advice, training opportunities and the chance to meet like-minded people.

Membership Information

- Annual membership costs £10 per calendar year and applies to each separate address not per individual
- Membership runs for a complete calendar year but any new members who join after 30 September will be members until the end of the following year.
- Payment can be made by a number of methods:
 - **Standing order** – This is the preferred method because membership renewal payments are automatic which reduces our overheads.
 - **Cheque** – sent in with the completed application form
 - **Direct bank transfer** – using internet bank
